Dear Friends,

Welcome to spring at Quissett Harbor! The flora and fauna have sprung to life, the Harbor is a glistening sky blue and families are walking the Knob and gathering on the beach.

Spring awakening of the Harbor and the Knob always reinforces our commitment to the mission of the Quissett Harbor Preservation Trust, and this is a particularly important year. Through a coordinated effort with Salt Pond Areas Bird Sanctuaries this past winter, we contracted the services of Woods Hole Group to create a comprehensive Updated Management Plan for the Knob.

Since 2006 when we completed the major reconstruction of the stone revetment, we have spent \$105,000 on landscaping and maintenance projects. In the next few years we will be entering a period of even more significant investment. As you know, we had already been discussing the need for an increase in our financial reserves to provide for long-term capital needs. With the resources now required to execute the Updated Management Plan, we will be seeking additional funding.

We are concerned with a significant decline in member contributions in the first four months of 2016. Despite our having a historically strong and liquid financial position and adequate funds to begin work on the recommendations, dues renewal is essential to moving forward. We ask that members send in their usual generous contributions before our next Annual Meeting of Members on June 30. An envelope is enclosed in the print version of this newsletter. We will be presenting the Updated Management Plan and financial strategy at the Annual Meeting of Members on June 30. We hope you will attend to hear the recommendations for preserving the Knob over the coming years.

We appreciate your strong financial commitment to protecting the beauty of this area and look forward to sharing our plans with you.

Updated Management Plan

In the 10 years since the completion of the major revetment repairs, the Knob has continued to be affected by natural forces of wind and ocean; increased human traffic; and pest infestation in the form of the gall wasp, which has killed a large number of trees.

The **Updated Management Plan** for the Knob, which was reviewed at our March and May Board of Directors meetings, addresses these concerns, specifically:

- Shoreline and bank erosion, related to the stone revetment and many other areas of the Knob;
- Trail disrepair;
- Vegetation maintenance;
- Vehicle access for long-term maintenance of the stone revetment.

The **recommendations** to deal with these areas are prioritized in four categories:

- Immediate maintenance and repair;
- Work to be done over the next 2 years;
- Projects to be considered in 2-to-10 years;
- Projects to be considered in 10-to-20plus years.

We will present the plan at the Annual Meeting of Members June 30.

Fencing

Fencing has been renewed on the beach.

Gall Wasp Infestation

Salt Pond will be removing oaks killed by the gall wasp infestation. The Knob will be closed to visitors during the work. When we have the dates, we will post that information on our website and send an email blast to members.
