MESSAGE FROM RANDY

Dear Members:

Welcome to spring! I hope you are looking forward to enjoying the Harbor and the Knob at its most beautiful.

We continue to move forward in our work to repair the Knob. However, we have encountered a delay. State and federal regulators have imposed additional layers of permitting, which has affected our timing and hiring of contractors. Fortunately, we've had a relatively mild winter, limiting any erosion or other damage, so we don't expect the delay to hamper the ultimate results. We hope to resume work in the fall when the height of the season has passed.

With the focus on the Knob project, we are setting aside for the moment work on controlling invasive species. We are, however, continuing to study the issue to determine the best strategy. Also, we are pleased to note that the Quissett Harbor House Land Trust, of which our own Board member Dana Rodin is president, has cleared a lot to the north of Quam Quissett Beach Club of invasive plants. This will prove to be a valuable pilot project that can inform our own future actions.

On behalf of the Board, let me express how grateful we are for the tremendous response to our Capital Campaign, *Preserving Our Shared Community*. Thank you to all our members. To date pledges have exceeded \$500,000. This shows the tremendous commitment to the stewardship of our Harbor on behalf of our community. Contributions continue to come in to the campaign, all of which will be needed as we move forward with our work to repair the Knob.

Finally, I want to Thank Weatherly Dorris and John Sigel, who are stepping down from the Board this year. You'll find a detailed thank you in this newsletter, but I want to emphasize how valuable their contributions have been. Their involvement is foundational, and their stewardship of Quissett Harbor a tremendous gift. Thank you.

UPDATE ON HABITAT CONSERVATION & MANAGEMENT

Emergency Knob Repair

Working with Foth/CLE Engineering, we obtained our basic permitting from the Falmouth Conservation Commission for the Knob rock-armor repairs at the end of February 2019. However, other state and federal regulators have imposed additional permitting requirements that will delay the work until fall 2019. In any event, work cannot, of course, go forward during the summer season due to heavy visitation. When all the permitting is obtained, after bidding and contractor selections have been made, the work will be undertaken.

Maintenance of Paths and Beaches

Regular maintenance and necessary replanting continues on the eight maintenance and erosion-control projects identified as part of our Management Plan. This work is being done by Crawford Land Management (CLM), hired jointly with Salt Pond Areas Bird Sanctuaries. Maintenance and replanting also continues related to Harbor side erosion control and paths.


Invasive Control and Revegetation

Keeping invasive species under control is critical to allowing native plants and superior habitat to flourish. We are continuing to study potential solutions for the areas of the greatest concern. This is the first step in developing a land-management, invasive-control-and-restoration-planting plan. Additionally, the Quissett Harbor House Land Trust has recently cleared a lot to the north of Quam Quissett Beach Club of invasive plants, and we hope to learn from this action what might be useful in other areas.



Weatherly Dorris and John Sigel have been important contributors to the work of protecting the Harbor and the Knob. We are sorry to see them leave but are truly grateful for the role they have played in the success of the Trust.

Weatherly has been a member of the Board since the Trust's founding in 2001. She was our first Secretary, was elected President in 2010 and served as Treasurer after that.

The late Chip Morse, Founder and former Chairman of the Trust, once said, "She comes up with great ideas, particularly in the area of looking for ways to educate people on the value of this resource."

His commitment to maintaining continuity of records has created the accurate institutional history so important to an organization such as ours. He has also led the Beach Cleanup and hosted Board meetings in his home. "Both Weatherly and John have devoted many years of effort to the Trust and to this community," said President Randy Evans. "Because of their love of and commitment to the Harbor, we know they will continue to be a part of its preservation."

FINANCES 2018 (JANUARY 1-DECEMBER 31, 2018)

Contributions, including dues and cash received through our Capital Campaign, totaled \$295,337. Our total Change in Net Assets was up by \$204,264 in 2018. Our expenses increased by \$22,157 over last year due to Erosion Control and payments to our consulting engineers for preliminary design and permitting with Falmouth Conservation Committee for the rockarmor repair.

The Trust's assets include \$100,000 at Rockland Trust, with the balance invested with Fidelity. They are invested in compliance with the QHPT Investment Policy. Roughly \$500,000 is in cash, with \$400,000 of this balance generated through sales of the Trust's stock and fixed-income holdings in October/November of 2018 to provide funds for Armor repair on the Knob. The remainder of the Trust's assets are invested roughly 50/50 in fixed income and equity mutual funds/ETFs in accordance with the Investment Policy. While our investments did show a unrealized loss in 2018, in 2019 year-to-date we have an unrealized gain of \$44,000.
